2. Medical care concept

Good medical and rescue services are the key for success and successful event. The Chief Medical Officer (CMO) of EYOF Maribor 2023 with the medical team, in supervision by the EOC Medical Delegate, will take care of the health of participants at all official venues. Medical services will be of good quality and include the provision of free of charge and in a timely manner healthcare for accredited persons involved in the event. Additionally, basic care is extended to spectators at the venues.

Medical services will be provided at the Athletes' Village Clinic (AVC) located in the AVL 1 (basic level), sport venues (basic and emergency level), official side events (basic level) and in cooperation with the Host City Hospital (advance level) to the delegation members from 22 July to 30 July and to CdMs and up to 2 other delegation members from 21 July to 30 July 2023.

On-site emergency medical services are provided free of charge to all accredited persons and spectators at medical facilities set up at the EYOF venues. The actual standard is meant to provide, in cooperation with the Host City Hospital, free hospital care to the accredited members of the NOCs, the EOC (IOC) and the IFs and EFs.

Such hospital care will include:

- Free transportation from the venues to the Host City Hospital or in other higher-level hospitals if necessary.
- Free emergency and outpatient treatment/services in the Host City Hospital, equivalent to the treatment/services that patients would receive in a public hospital.
- Free medication during hospital stays, equivalent to the medication that patients would receive in a public hospital.
- Free transportation to medical specialist in the host city or to another city.

Such coverage shall apply to injuries, acute illnesses, and emergencies occurring during the term of the EYOF Maribor 2023.

In case a Participant is hospitalised, the insurance covers all costs of medical treatment up to 100.000 €.

Outside this period, the NOCs are advised to obtain private health insurance to cover potential healthcare expenses, including ambulance transport and stays in a hospital. Furthermore, private healthcare treatment and private consultations outside the aforementioned arrangements, or where there is no prior arrangement with the OC, will be at the expense of the NOC.

He has free access to all elements of the MSAD system and he mainly cooperates with the CMO.

He is a member of the OC and is responsible for the provision of the MSAD as well as securing the quality and hygienic safety of food service in the Athletes' Villages.

He determines and reviews within the framework of the OC the specific MSAD concept, both in the OC and with any external organisations relevant for the operation of the individual elements comprising the system.

- Oversees communication and administrative work in relation to the NOCs.
- Prepares and chairs the "Medical Meeting for Team Doctors".
- Upon the appointment of the NOC CMOs, also communicates directly with those physicians and deals with their questions.

The CMO is also responsible for the following:

- Supervision of curative medicine services.
- Supervision of emergency medicine services.
- Organising rescue services at the venues.
- Tracking injured or sick EYOF participants.
- Contact to Team Physicians
- Nutrition control in quality, quantity, and safety.

The main task involves the provision of urgent medical care, transport and transport-tracking, coordination between the Venues Medical Services, the AVC (Athletes' Village Clinic), and the Host City Hospital Emergency Station.

2.3. Medical protocol

In case of need for medical assistance (other than an emergency situation) every accredited individual should present with his/her personal accreditation. So, one must show the accreditation whenever using the services of:

- Athletes' Village Clinic (AVC)

- University Medical Centre Maribor
- Dental services

In case of medical issues use the following protocol to ensure faster diagnostic and treatment process:

- Make sure to have your Accreditation Card ready when using any EYOF medical services
- Athletes' Village Clinic (AVC) is the main point of medical services
- At the sports venues
- contact the venue medical staff,
- contact competition/venue manager, or
- call LMO/CMO
- For other health issues and questions contact the CMO/LMO

3. Medical service locations

3.1. Athletes' Village Clinic (AVC)

The Athlete's Village Clinic (AVC) provides fundamental range of medical service with a medical doctor and a paramedic between 6:00 and 22:00. The location of the AVC is in the AVL 1, ground floor. The AVC is available free of charge to all NOC delegation members. The AVC also organises emergency medical transport and hospital transfers. The AVC is responsible for the transfer and in field emergency medical services for the accredited persons, in the official accommodations, like hotels outside of the AVLS.

Medical doctor with a nurse will be present from 21 July to 30 July daily 6:00–22:00

- Works as a general practitioner
- Able to provide primary care to accredited persons.
- Treats some basic conditions (pain, infection, etc)
- Refers patients to the hospital if needed, organizes transport, communicates with CMO and team doctors, etc.
- Can prescribe drugs if needed by a team doctor (team doctors will have to pay for these at the pharmacy)

Physiotherapists present from 21 July to 30 July daily 8:00–22:00

- Additional physiotherapist present 13:00–20:00
- In case of injury provides some basic physical therapy options (manual therapy, laser, tecar etc.)
- Communicates and cooperates with team physios

3.2. Venues

The Venues Medical Services provide medical service at all competition and training venues as well as non-competition venues (Opening and Closing Ceremonies, evening events at the Fan Zone) at the EYOF Maribor 2023. Such onsite medical services primarily provide first aid in emergencies relating to illnesses and injuries as well as emergency support to all accredited athletes and team officials during the competitions.

At sports venues where no ambulance car is present, one will be available on call and able to reach the location in few minutes.


3.3. Host city hospital

The University Medical Centre Maribor is the host city hospital. The hospital provides all facilities of the diagnosis and treatment in all medical fields. The hospital has access to all diagnostic and therapeutic tools including CT, US, MRI, X-ray and haematological and microbiological tests.

With its team of physicians and healthcare professionals, the hospital endeavours to offer maximum comfort and care for pediatric patients and adults.

We advise not to go to the hospital alone (without informing LMO or CMO). In this way we will ensure that a dedicated medical doctor will admit the patient upon arrival and coordinate the mentioned process of diagnostic and treatment.

There will be a designated partner pharmacy close to AVL 1 (approx. 600 m) for the duration of the festival. Medication prescribed by a medical staff at the medical clinic as well as non-prescription drugs will be available for a pick-up upon payment.

4. Team Doctors and Medical Personnel

4.1. The Registration and Rights of Medical doctors

NOC Team Doctors & Medical Personnel are registered and accredited with the delegation through GMS. If NOC register medical doctors, OC needs to receive Medical Announcement and Doctors Declaration form. The form must be confirmed and signed by the President, Secretary General or CdM and by the CMO. The form is available on Extranet and must be signed and uploaded to Extranet by 10 July 2023.

NOC Medical Doctors are allowed to treat only their own team members. NOC can also deliver its medical services to other delegation(s) with the written consent of the relevant NOC(s). Proof of consent should be uploaded to Extranet with the Medical Announcement and Doctors Declaration form. A sample consent form is available in Extranet.

4.2. Medical Meeting

CMO and Medical Delegate of EOC CoCom will hold a meeting with the NOC medical representatives on 23 July 2023 at 10:00 in the NOC SC in AVL 1. The concept of healthcare provision will be presented at the meeting and there will be place for questions about the Medical Handbook and medical services.

4.3. Import of Medical Supplies

Pharmaceutical products used at international sports events are free of import duties into the EU, within the limits necessary to meet their requirements throughout their stay (Council Regulation (EC) No 1186/2009). OC does not require NOCs to provide a list of medicines or medical devices they will bring to EYOF. It is recommended that a complete list of the medications that come with your team doctor is made in case this is asked for at the Customs upon entry or later. A sample is in appendix and available in Extranet. Addictive drugs, including narcotics and psychotropic substances, are prohibited and may not be imported.

5. RED-S in sports: Awareness & Research

Relative Energy Deficiency in Sport (RED-S) is a syndrome that occurs when athletes do not consume enough energy to meet the demands of their training and overall physiological needs. It goes beyond just inadequate calorie intake and encompasses a range of physiological and psychological consequences. RED-S can result in hormonal disruptions, impaired bone health, menstrual disturbances, decreased immune function, and performance decrements. It affects both male and female athletes across various sports. Recognizing and addressing RED-S is crucial to ensure athletes' long-term health and performance. Treatment involves a comprehensive approach that includes nutritional rehabilitation, appropriate training modifications, and psychological support.

At EYOF Maribor 2023 we would like to address this progressively important issue in sport. Teams of medical and clinical nutrition students will approach athletes (in a polite, harmless and friendly way) at the athlete villages and some sport venues to ask them to answer a brief questionnaire. Additionally, we will perform a survey on the topic among team doctors at the medical meeting.

Beside approaching the athletes, there will be a stand in AVL 1 where athletes will be able to get more information on healthy nutrition in sports as well as to perform body composition analysis.

6. COVID-19 terms

Since the epidemic situation is getting more favourable with every month, no special protocols are planned so far. In case of a symptomatic person testing positive, the teams will have the possibility to isolate the person in rooms provided by the OC. Any needed medical assistance will be provided by the University Medical Centre Maribor.

There is no obligation for a quarantine after crossing the Slovenian border as well as no obligation to send vaccination certificates when crossing the border or perform tests for SARS-CoV-2.

In the case of the new regulations, they will be implemented as part of the system for organising and securing EYOF Maribor 2023 and communicated in advance.

The objectives of doping control are to preserve the dignity of Olympic sport and to protect the fundamental right of athletes to participate in doping-free sport, thereby promoting health, serenity, and equality in competition.

7.1. Responsible organisations

The European Olympic Committees has delegated the independent management of the Summer EYOF 2023 anti-doping program to the International Testing Agency (ITA). ITA’s mission is to manage fair and transparent anti-doping programs, independent from sporting or political powers, for International Federations, Major Event Organisers and all other anti-doping organisations requesting support. Most recently, the ITA has successfully delivered the anti-doping program for the Tokyo 2020 and the Beijing 2022 Olympic Games, the World Games 2022 and is set to deliver a comprehensive program for Events organized under the auspices of the EOC.

All samples will be collected by the well-qualified Doping Control Officers (DCOs) of the Slovenian Anti-Doping Organization (SLOADO). SLOADO is an internationally recognised anti-doping organisation, fully compliant with WADA, which carries out doping tests on the basis of the International Standard for Testing and Investigation of WADA.

7.2. Doping control stations

Central Doping Control Stations (DCS) will be established for all sports at the location of the Stadium Ljudski vrt (North entrance from Mladinska street). Athletes who will be selected for the doping control will be transported from the sport venue to the DCS escorted by Anti-doping Chaperone.

All doping controls will be conducted in separate processing rooms set up exclusively for doping control purposes providing the required privacy and confidentiality for athletes as well as security for the sample collection procedures. DCS will comply with all provisions set out in the EOC Anti-Doping rules, the World Anti-Doping Code, and its accompanying International Standards. The organisers will ensure the optimal temperature of the rooms, enough sealed drinks, and snacks.

7.3. Current anti-doping legislation

8. Athlete Selection and Notification

The doping controls will be carried out in and out-of-competition with no advance notice. Upon notification of a doping control, the athlete will be required to present himself/herself immediately at the DCS, unless the DCO gives the athlete permission to postpone the doping control for the reasons set out in the International Standard for Testing and Investigations (ISTI).

Delayed reporting to or temporary departure from the DCS may be permitted for the following activities:

For In-Competition Testing:

- Participation in a presentation ceremony
- Fulfilment of media commitments
- Competing in further competitions
- Performing a warm down
- Obtaining necessary medical treatment
- Locating a representative and/or interpreter
- Obtaining photo identification
- any other reasonable circumstances, as determined by the DCO, taking into account any instructions of the ITA.

For Out-of-Competition Testing:

- Locating a representative
- Completing a training session
- Receiving necessary medical treatment
- Obtaining photo identification
- any other reasonable circumstances, as determined by the DCO, taking into account any instructions of the ITA.

The athlete shall be accompanied by a chaperone from the time of notification until the completion of the doping control.

8.1. “In-Competition” and “Out-of-Competition”

In-Competition means

“The period commencing at 11:59 p.m. on the day before a Competition in which the Athlete is scheduled to participate through the end of such Competition and the Sample collection process related to such Competition”.

For the "In-Competition" tests, the doping control shall be conducted (if possible) before the award ceremony. Otherwise, a chaperone will accompany the athlete to the award ceremony and then to the doping control station.

Out-of-Competition means

"Any doping control that does not take place in-Competition".

The term Competition is defined as "A single race, match, game or singular sport contest".

8.2. Athletes whereabouts information

Team's accommodation and athletes' whereabouts information will be provided by the OC.

9. Sample collection

Athletes may undergo doping tests at any time and in any place during the entire period of the EYOF Maribor 2023.

Both urine and blood tests will be collected. Additional testing resulting from intelligence and/or investigative activities may be conducted at the discretion of the ITA without prior notice.

All samples collected will be analysed at the WADA accredited laboratory in Seibersdorf, Austria. The ITA will be responsible for the secure transportation of the samples to the laboratory.

9.1. Transport

The OC will provide transport for athletes and their representatives who have undergone doping control from the competition venues to the Central DCS. After the completion of the doping control procedure, transport to the athlete's accommodation is organised for the athletes by EYOF bus lines. Separate transport will be organised during non-shuttle bus hours.

9.2. Doping control procedure

The ITA will plan and implement all doping control procedures according to the EOC Anti-Doping rules, the World Anti-Doping Code and the International Standard for Testing and Investigations. The following key points in the doping control procedure are to be highlighted:

1. The notification process will be conducted without any advance notice. It is recommended that notification of the athlete who is a minor is conducted in the presence of an adult/guardian.
If the athlete would like to have a representative present during the notification and/or throughout the sample collection procedure, the chaperone must escort the athlete to locate a representative who can accompany him/her at notification and/or throughout the sample collection procedure.
2. The athlete representative during the notification and during the sample collection session are suggested to remain the same person. It is recommended that the minor athlete is accompanied by a representative throughout the sample collection procedure, except for the witnessing of the sample, unless the minor athlete requests it. The objective of this is to ensure that the witness DCO is observing the sample provision correctly as required in the ISTI.
3. The athlete shall provide the first urine sample subsequent to notification.
4. The athlete is required to provide his/her accreditation card to confirm his/her identity and sign the notification form after being notified.
5. The athlete should avoid excessive hydration to avoid diluted sample(s).
6. For urine collection a minimum of 90 ml will be required.
7. The athlete is required to wash his/her hands before the sample provision or wear gloves during the provision of the sample.
8. During the witnessing of the sample provision, the DCO must ensure that the sample is provided directly from the athlete's body into the sample collection vessel, hence the DCO will request that any clothing be removed or lifted to ensure the DCO has an unobstructed view.
9. The DCO will instruct the athlete how to seal the sample into bottles, and the athlete shall handle the sample and seal. The athlete shall follow the DCO's instructions and if there is anything unclear, the athlete should ask questions.
10. The athlete and their representative, if present, shall ensure that any information recorded on their doping control form is accurate and correct.
11. Requirements for insufficient samples: when an athlete provides less than the required volume (minimum of 90 ml) of urine, a partial sample procedure (temporary sealing procedure) will be conducted. In the case of this procedure, the athlete shall remain at the DCS observed. The partial sample will be stored and controlled in the DCS by the DCO. The testing is completed when the required volume of urine is collected.
12. Suitable specific gravity (SG) for analysis: for samples with a minimum volume of 90 ml, SG must measure 1.005 or higher. For samples with a volume of 150 ml and above, SG must measure 1.003 or higher.

13. If a sample collected from the athlete does not meet the SG requirements, then the athlete is required to pass a urine sample until a sample with the required SG is collected. While waiting to pass a sample(s) to ensure that a urine sample with the required SG is collected, the athlete shall remain under observation. While waiting to pass an additional sample, the athlete must not drink excessive amounts of liquids.
14. The Blood collection officer (BCO) shall inform the athlete to remain in a normal seated position with feet on the floor for at least 10 minutes prior to providing a blood sample.
15. The BCO is only permitted to perform three attempts on the athlete's arms to draw the required amount of blood. If after three attempts the BCO has been unable to draw the required amount of blood, the DCO will terminate the blood sample collection session.
16. Athletes are required to disclose the prescription drugs, OCT drugs and supplements they have taken in the past 7 days.
17. The athlete can make clear their choice of whether they agree to have their samples used for anti-doping research on the DCF.

9.3. Minor athletes

Athletes selected for sample collection will be accompanied to the DCS by qualified, accredited and English-speaking chaperones. In accordance with international regulations and to protect the rights of minors, an adult representative must be present during the notification and sample collection session.

The adult representative must identify him/herself with his/her accreditation card or other official document with photograph when entering the doping control station.

10. Therapeutic Use Exemptions (TUE)

Please kindly note that all updated information related to the TUE process can be found on "[Therapeutic use exemption process](#)" page on the EOC website at eurolympic.org.

New TUE processes should be sent to tue@ita.sport by 26 June 2023.

11. Processing personal data

Athletes are requested to provide all necessary information, such as: medical conditions, TUEs or treatments, in order to best conduct the anti-doping controls.

In providing this information, participants will be required to complete forms (Doping Control, TUE) detailing the conditions for these procedures and the associated use of participants' personal data. Under the terms of the consent form, it is the responsibility of the Chef de Mission to ensure and inform both athletes and parents/guardians that they understand the conditions applicable to these procedures, including the use of personal data.

12. Anti-doping Education

The ITA and SLOADO will deliver onsite clean sport training workshops for 5 days during the Event.

All athletes and athlete support personnel are encouraged to participate in education activities delivered by the ITA and SLOADO during the event.

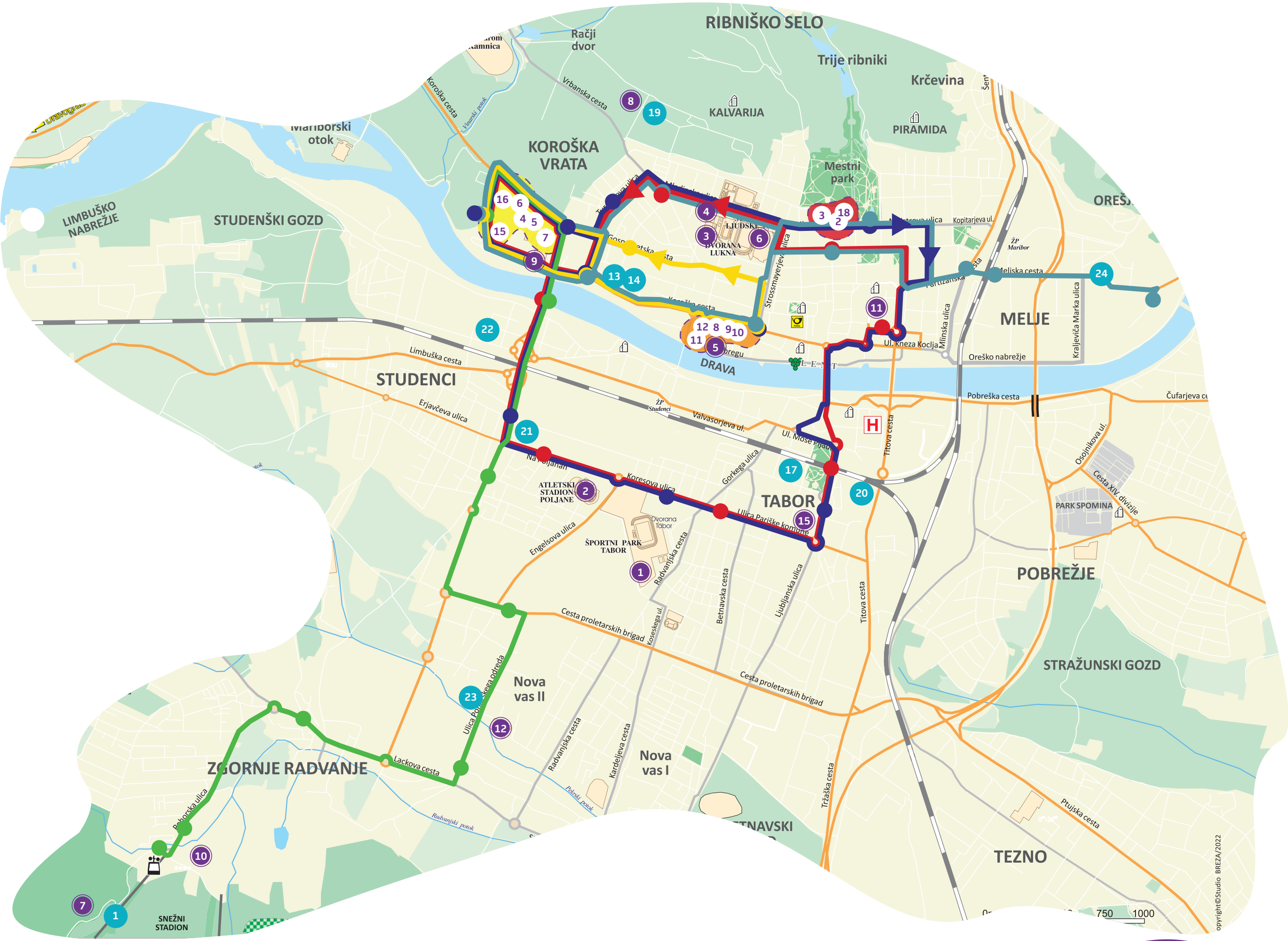
General map of sports and other venues with location of AVC and hospital

NOC _____

The National Olympic Committee (NOC) will send medical staff to provide medical services during the EYOF Maribor 2023.

The NOC hereby undertakes that:

1. The NOC shall only deliver medical services in the EYOF Maribor 2023 venues to its own delegation.
NOC can also deliver its medical services to other delegation(s) with the written consent of the relevant NOC(s). Proof of consent should be uploaded to Extranet with the Medical Announcement and Doctors Declaration form.

NOC has obtained written consent from the following NOC(s) to provide first aid medical services in the EYOF Maribor 2023 venues to their delegations:

2. The NOC shall take all responsibility for the medical services provided by NOC medical staff in Maribor 2023 venues and/or reimbursement of medical/surgical expenses incurred in connection with these services.
3. The NOC is liable towards the European Olympic Committees (EOC) and/or EYOF Maribor 2023 against all claims, liabilities, losses, damages and costs (including legal costs) arising from the medical services provided by NOC medical staff in Maribor 2023 venues.
4. The NOC shall take full responsibility for any loss or damage to all equipment and other property that the NOC medical staff has brought into the EYOF Maribor 2023 venues, and shall comply with all applicable laws and regulations (including occupational health and safety regulations), all venue rules, conditions and procedures while performing medical services in the EYOF Maribor 2023 venues.
5. If the NOC needs to import pharmaceuticals or dietary supplements to meet the needs of its members, the NOC
 1. Is recommended to make a complete list of the pharmaceutical products;
 2. Shall maintain all pharmaceuticals in their original packaging;
 3. Shall take full responsibility in relation to the chemical composition of dietary supplements, and agree that EYOF Maribor 2023 or EOC shall take no responsibility for possible containment of prohibited substances in such dietary supplements.
